- (4) Pledge is for 2006 only; a further pledge is expected for 2007.
- (5) Germany will endeavour to mobilise this amount in preparing the federal budget for 2006 -2007.
- (6) Japan's pledge is for the coming few years, the annual allocation of which will be decided at an appropriate time.
- (7) Amounts indicated by an asterisk, including from the private sector, are estimated to total USD 350 million; some of these are decided but not yet announced.
